SOFTWARE REGISTRATION PROCEDURE

SOFTWARE REGISTRATION

Once a VBM Cell has been installed you may continue to use all the features as 'try-before-you-buy' for a single User using one VBM Cell and Vault under our **TRUE Freeware** license. If you wish to upgrade to an **ENTERPRISE Multi-User** license you must first register the VBM Cell so that a Customer ID can be issued to you by CY Innovations.

The registration procedure is detailed in the on-line VBM Help Guide.

1. Install the VBM Cell databases on a server and the application software on client PC/s according to the on-line VBM Help Guide.
2. Login as 'bizadmin' and select **Help | Register VBM** from the main menu.
3. On the Product Registration window enter the Company Name (or your name) to be registered.
4. Click *Register Now*
5. An email will be sent to our sales team for minimum 5 End User licenses.
6. We will email you a reply including an invoice and EFT payment instructions
7. Once your payment is received we will send an email with your Customer ID and a License Number.
8. Enter the Customer ID and License Number in the Product Registration window and click *Apply*.
9. Your VBM Cell will be registered under an **ENTERPRISE Multi-User** license for minimum 5 End Users.
10. From the main select **Help | About VBM** to view the details of your license.



LICENSE UPGRADE PROCEDURE

LICENSE UPGRADE

Once a VBM Cell has been registered and you have been issued a Customer ID you can upgrade your license at any time by placing an order for the required number of seats at the [prices listed](#).

Upgrading to an **ENTERPRISE Multi-User** license is achieved by placing an order for the initial number of seats required or the incremental number of seats for an existing **ENTERPRISE Multi-User** license. A minimum seat quantity of 5 is included in the initial fee includes the databases license for one VBM Cell and the first year maintenance agreement.

1. The VBM Cell must already have been Registered with an **ENTERPRISE Evaluation** license according to the on-line VBM Help Guide
2. Login using the 'bizadmin' account and select **Help | Register VBM** from the main menu.

4. Enter the TOTAL number (existing + new) of seats you require.
